Background

At the March 21, 2012 Board Study Session, the Board of Trustees voted to change the current chapter and numbering schema and structure used for Board policies and related administrative procedures and to fully align with the Community College League of California (CCLC) schema and structure.

This report provides the analysis and actions took to achieve this goal. In addition, the report provides a status update on revising all existing Board Policies and Administrative Procedures and creation of new ones, as needed.

The report is accompanied by a detailed document that provides the analysis of each BP and AP and the forward schedule Fall 2014-Spring 2018 for the ongoing regular review of BPs and APs pursuant to BP/AP 2410.

Brief Overview of CCLC Board Policy and Administrative Procedures Schema and Structure

The CCLC Policy and Procedure Subscription Service provides template language for over 370 board policies and administrative procedures for California community colleges. Subscribing districts, including CCCD, receive legal updates annually that alert them to changes in laws, regulations, or practice. The Service also sponsors two workshops for subscribers each year, maintains a website and listserv, and provides referrals for consultants to implement the Service.

Subscribing districts report that the Service is invaluable in ensuring that they have up-to-date and useful policy and procedure manuals. They also report that the Service has helped educate trustees and other district leaders and made it possible to improve the policy and procedure review processes.

CCLC uses the term “policy” to refer to board policy that is adopted by boards of trustees. The term “procedure” is used to refer to administrative procedures, district regulations or similar titles, which are the purview of the district CEO and other employees.

CCLC uses the following chapters to organize the templates for board policies and administrative procedures:

Chapter 1. The District – all policies and procedures in this chapter are numbered in the 1000 series

Chapter 2. Board of Trustees – all policies and procedures in this chapter are numbered in the 2000 series

Chapter 3. General Institution – all policies and procedures in this chapter are numbered in the 3000 series

Chapter 4. Academic Affairs – all policies and procedures in this chapter are numbered in the 4000 series

Chapter 5. Student Services – all policies and procedures in this chapter are numbered in the 5000 series

Chapter 6. Business and Fiscal Affairs – all policies and procedures in this chapter are numbered in the 6000 series

Chapter 7. Human Resources – all policies and procedures in this chapter are numbered in the 6000 series

Revision of Chapter Structure

CCCD board policy and administrative procedure chapter structure was not consistent with the CCLC structure. In order to align with the CCLC chapter structure, the following changes were implemented:

Policies and procedures were re-organized and re-numbered accordingly and revised. New BPs and APs were created as necessary.

For all the above prior CCCD chapters, some of the policies needed to be moved to the correct chapter per CCLC structure and renumbered accordingly.

Revision of Numbering Structure and Review/Update of Existing BPs and APs and Creation of New Ones as Needed

In April 2012, the Vice Chancellor of Educational Services and Technology convened a working group with representation from the units of the District Office who have overall responsibility for each area to work on the re-alignment of BPs and APs. This work was completed and the revised structure was implemented in April 2013. During this review

and re-alignment to conform to the CCLC recommended structure, overlapping board policies were identified which were consolidated or eliminated, as appropriate, and those which were appropriate as an administrative procedure rather than as a board policy were revised and brought to the Board of Trustees for review and approval or ratification, as appropriate. The deployment of the revised structure was followed by the release of a new web site in January 27, 2014 where the new chapter structure and renumbered and revised and new board policies and administrative procedures are posted under the Board of Trustees section of the district web site.

Four-year Planned Schedule for Review/Update of Existing Board Policies and Administrative Procedures

The table below provides a summary of the proposed four-year schedule for reviewing existing Board Policies and Administrative Procedures. The TBD label refers to BPs in Chapter 7. Human Resources that have not yet been reviewed and made current as of Feb 19, 2014. Once these older BPs are updated their future schedule will be developed.
